Obtain as much supplemental information as you can before you report the claim such as policy number; name, address, phone; date of loss; and location of loss.

3. REPORT THE CLAIM IMMEDIATELY.

Don't delay in calling just because you don't have all the information. Timely reporting is essential. You can gather and report any missing information at a later date.
