
CYBER ATTACKS IMPACT ALL INDUSTRY SECTORS

CASE STUDY: MEMBERS DENIED

A local gym's membership system was hit by a Distributed Denial of Service (DDoS) attack, basically shutting the gym down for 6 days. A group of members sued the gym for fee reimbursement due to lost access.



CASE STUDY: CLIENTS DECEIVED

After clients booked appointments through a salon's website, they would receive emails from fraudsters pretending to be salon representatives who coerced clients to provide sensitive personal information.
